FOR AGRICULTURAL DEVELOPMENT AND MODERNIZATION

BY THE BLESSINGS OF ALMIGHTY GOD

MINISTER OF AGRICULTURE OF THE REPUBLIC OF INDONESIA,

Considering : a. that to realize an effective and efficient organization and work procedure in order to improve the performance of the implementation of tasks and functions of technical implementing units within the scope of the Indonesian Agency for Agricultural Development and Modernization, it is necessary to manage the organizational structure and work procedures of technical implementing units within the scope of the Indonesian Agency for Agricultural Development and Modernization;

b. that based on the provisions of Article 41 and Article 42 of Presidential Regulation Number 192 of 2024 on the Ministry of Agriculture, to carry out operational technical tasks and/or supporting technical tasks within the Ministry of Agriculture, the Minister of Agriculture has the authority to form and determine technical implementing units;

c. that to manage the organization and work procedures of the technical implementing units within the Indonesian Agency for Agricultural Development and Modernization has received written approval from the Minister of Administrative and Bureaucratic Reform;

Observing : 1. Article 17 section (3) of the 1945 Constitution of the Republic of Indonesia;

2. Law Number 39 of 2008 on State Ministries (State Gazette of the Republic of Indonesia of 2008 Number 166, Supplement to the State Gazette of the Republic of Indonesia Number 4916);

3. Presidential Regulation Number 192 of 2024 on the Ministry of Agriculture (State Gazette of the Republic of Indonesia of 2024 Number 389);

4. Regulation of the Minister of Agriculture Number 02 of 2025 on Organization and Work Procedures of the Ministry of Agriculture (State Gazette of the Republic of Indonesia of 2025 Number 14);

HAS DECIDED:

To issue : REGULATION OF THE MINISTER OF AGRICULTURE OF THE REPUBLIC OF INDONESIA ON ORGANIZATION AND WORK PROCEDURES OF THE TECHNICAL IMPLEMENTING UNITS WITHIN THE SCOPE OF THE INDONESIAN AGENCY FOR AGRICULTURAL DEVELOPMENT AND MODERNIZATION.

CHAPTER I  
GENERAL PROVISIONS

Article 1

In this Ministerial Regulation:

1. Technical Implementing Unit (Unit Pelaksana Teknis), hereinafter referred to as UPT, means an independent work unit that carries out specific operational technical tasks and/or certain supporting technical tasks from the parent organization.
2. Minister means the minister administering government affairs in the field of agriculture.
3. Head of the Indonesian Agency for Agricultural Development and Modernization, hereinafter referred to as the Head of the Agency, means a high-level senior executive officer within the Ministry of Agriculture having duty to conduct agricultural development and modernization.

CHAPTER II  
TECHNICAL IMPLEMENTATING UNITS

Article 2

- (1) UPT under the Indonesian Agency for Agricultural Development and Modernization consist of:
  - a. Indonesian Center for Agricultural Development and Modernization of Rice;
  - b. Indonesian Center for Agricultural Development and Modernization of Veterinary;
  - c. Indonesian Center for Agricultural Development and Modernization of Land Resources;
  - d. Indonesian Center for Agricultural Development and Modernization of Mechanization;
  - e. Indonesian Center for Agricultural Development and Modernization of Postharvest;
  - f. Indonesian Center for Agricultural Development and Modernization of Biotechnology and Genetic Resources;
  - g. Indonesian Center for Agricultural Development and Modernization of Implementation;
  - h. Indonesian Institute for Agricultural Development and Modernization of Legumes;
  - i. Indonesian Institute for Agricultural Development and Modernization of Cereals;

- j. Indonesian Institute for Agricultural Development and Modernization of Vegetables;
- k. Indonesian Institute for Agricultural Development and Modernization of Tropical Fruits;
- l. Indonesian Institute for Agricultural Development and Modernization of Ornamental Plants;
- m. Indonesian Institute for Agricultural Development and Modernization of Citrus and Subtropical Fruits;
- n. Indonesian Institute for Agricultural Development and Modernization of Spices, Medicinal and Aromatic Plants;
- o. Indonesian Institute for Agricultural Development and Modernization of Industrial and Beverage Crops;
- p. Indonesian Institute for Agricultural Development and Modernization of Sweetener and Fiber Crops;
- q. Indonesian Institute for Agricultural Development and Modernization of Palm Crops;
- r. Indonesian Institute for Agricultural Development and Modernization of Poultry and Various Livestock;
- s. Indonesian Institute for Agricultural Development and Modernization of Soil and Fertilizer;
- t. Indonesian Institute for Agricultural Development and Modernization of Environment;
- u. Indonesian Institute for Agricultural Development and Modernization of Swampland;
- v. Indonesian Institute for Agricultural Development and Modernization of Agro-climate and Hydrology;
- w. Indonesian Institute for Management of Agricultural Development and Modernization Product;
- x. Indonesian Institute for Implementation of Agricultural Modernization;
- y. Indonesian Institute for Agricultural Development and Modernization of Tubers;
- z. Indonesian Institute for Agricultural Development and Modernization of Large Ruminants; and
- aa. Indonesian Institute for Agricultural Development and Modernization of Small Ruminants.

(2) The organizational structure chart of each UPT under the Indonesian Agency for Agricultural Development and Modernization as referred to in section (1) is set forth in Annex I, which constitutes an integral part of this Ministerial Regulation.

**CHAPTER III**  
**POSITION, DUTIES, FUNCTION, AND ORGANIZATIONAL**  
**STRUCTURE**

**Part One**  
**Indonesian Center for Agricultural Development and**  
**Modernization of Rice**

**Article 3**

(1) Indonesian Center for Agricultural Development and Modernization of Rice is a UPT under the Indonesian

Agency for Agricultural Development and Modernization and is responsible to the Head of the Agency.

(2) Indonesian Center for Agricultural Development and Modernization of Rice is led by a director.

#### Article 4

Indonesian Center for Agricultural Development and Modernization of Rice is technically supervised by the Director of Indonesian Center for Agricultural Development and Modernization of Food Crops.

#### Article 5

Indonesian Center for Agricultural Development and Modernization of Rice has the duties to implement the agricultural development and modernization of rice.

#### Article 6

In performing the duties as referred to in Article 5, Indonesian Center for Agricultural Development and Modernization of Rice carries out the following functions:

- a. formulation of program plans and budgets in the field of agricultural development and modernization of rice;
- b. implementation of technological and engineering development, development of production capacity, and agricultural modernization of rice;
- c. implementation of technological analysis and testing in the field of agricultural development and modernization of rice;
- d. management of breeder seed production and seed center for rice;
- e. preparation of concepts for the Indonesian National Standard in the field of rice and conformity assessment;
- f. utilization and cooperation related to the results of agricultural development and modernization of rice;
- g. monitoring, evaluation, and reporting in the field of agricultural development and modernization of rice; and
- h. implementation of administrative affairs and household management of Indonesian Center for Agricultural Development and Modernization of Rice.

#### Article 7

Indonesian Center for Agricultural Development and Modernization of Rice consists of:

- a. Administrative Section; and
- b. specialist officers and general service officers.

#### Article 8

The Administrative Section is responsible for carrying out the preparation of program and budget planning, evaluation and reporting, financial affairs, human resource affairs, administrative services, general affairs, facilities and infrastructure, state-owned property and asset management, correspondence, archiving, and public relations within the scope of the Indonesian Center for Agricultural Development and Modernization of Rice.

**Part Two**  
**Indonesian Center for Agricultural Development and**  
**Modernization of Veterinary**

**Article 9**

- (1) Indonesian Center for Agricultural Development and Modernization of Veterinary is UPT under Indonesian Agency for Agricultural Development and Modernization and is responsible to the Head/Director General of the Agency.
- (2) Indonesian Center for Agricultural Development and Modernization of Veterinary is led by a director.

**Article 10**

Indonesian Center for Agricultural Development and Modernization of Veterinary is technically supervised by the Director of Indonesian Center for Agricultural Development and Modernization of Livestock and Animal Health.

**Article 11**

Indonesian Center for Agricultural Development and Modernization of Veterinary has the duties to implement the development and modernization of animal and veterinary public health.

**Article 12**

In performing the duties as referred to in Article 11, Indonesian Center for Agricultural Development and Modernization of Veterinary carries out the following functions:

- a. formulation of program plans and budgets in the field of animal health and veterinary public health development and modernization;
- b. implementation of technological engineering and development, development of production capacity, and animal health and veterinary public health modernization;
- c. implementation of technological analysis and testing in the field of animal health and veterinary public health development and modernization;
- d. implementation of planning, formulation, maintenance, and conformity assessment of Indonesian National Standard in the field of animal health and veterinary public health development and modernization;
- e. utilization and cooperation related to the results of animal health and veterinary public health development and modernization;
- f. monitoring, evaluation, and reporting in the field of animal health and veterinary public health development and modernization; and
- g. implementation of administrative affairs and household management of Indonesian Center for Agricultural Development and Modernization of Veterinary.

**Article 13**

Indonesian Center for Agricultural Development and Modernization of Veterinary consists of:

- a. Administrative Section; and

b. specialist positions and general service positions;

#### Article 14

Administrative Section is responsible for carrying out the preparation of materials for program and budget planning, evaluation and reporting, financial affairs, human resource affairs, administrative services, general affairs, facilities and infrastructure, state property and asset management, correspondence, archiving, and public relations within the scope of the Indonesian Center for Agricultural Development and Modernization of Veterinary.

### Part Three Indonesian Center for Agricultural Development and Modernization of Land Resources

#### Article 15

- (1) Indonesian Center for Agricultural Development and Modernization of Land Resources is UPT under Indonesian Agency for Agricultural Development and Modernization and is responsible to the Head of the Agency.
- (2) Indonesian Center for Agricultural Development and Modernization of Land Resources is led by a Head.

#### Article 16

Indonesian Center for Agricultural Development and Modernization of Land Resources has the duties to implement the agricultural development and modernization of land resources.

#### Article 17

In performing the duties as referred to in Article 16, Indonesian Center for Agricultural Development and Modernization of Land Resources carries out the following functions:

- a. formulation program plans and budgets in the field of agricultural development and modernization of land resources;
- b. implementation of engineering and technological development, development of production capacity, and modernization of agricultural land resources;
- c. implementation of technological analysis and testing in the field of agricultural development and modernization of land resources;
- d. preparation of thematic geospatial information and recommendations on agricultural climate change adaptation;
- e. planning, formulation, maintenance, and conformity assessment of Indonesian National Standard in the field of agricultural land resource;
- f. utilization and cooperation related to the results of agricultural development and modernization of land resources;
- g. monitoring, evaluation, and reporting in the field of agricultural development and modernization of land resources; and

- h. implementation of administrative affairs and household management of the Indonesian Center for Agricultural Development and Modernization of Land Resources.

#### Article 18

Indonesian Center for Agricultural Development and Modernization of Land Resources consists of:

- a. Administrative Section; and
- b. specialist positions and general service positions;

#### Article 19

The Administrative Section is responsible for carrying out the preparation of materials for program and budget planning, evaluation and reporting, financial affairs, human resource affairs, administrative services, general affairs, facilities and infrastructure, state property and asset management, correspondence, archiving, and public relations within the scope of the Indonesian Center for Agricultural Development and Modernization of Land Resources.

### Part Four

#### Indonesian Center for Agricultural Development and Modernization of Mechanization

#### Article 20

- (1) Indonesian Center for Agricultural Development and Modernization of Mechanization is UPT under Indonesian Agency for Agricultural Development and Modernization and is responsible to the Head of the Agency.
- (2) Indonesian Center for Agricultural Development and Modernization of Mechanization is led by a Head.

#### Article 21

Indonesian Center for Agricultural Development and Modernization of Mechanization has the duties to carry out the agricultural development and modernization of mechanization.

#### Article 22

In performing the duties as referred to in Article 21, Indonesian Center for Agricultural Development and Modernization of Mechanization carries out the following functions:

- a. formulation of program plans and budgets in the field of agricultural development and modernization of mechanization;
- b. implementation of engineering and technological development, development of production capacity, competitiveness, and agricultural modernization of mechanization;
- c. implementation of technological analysis and testing in the field of agricultural development and modernization of mechanization;
- d. planning, formulation, maintenance, and conformity assessment of Indonesian National Standard in the field of agricultural mechanization;

- e. utilization and cooperation related to the results of agricultural development and modernization of mechanization;
- f. monitoring, evaluation, and reporting in the field of agricultural development and modernization of mechanization; and
- g. implementation of administrative affairs and household management of the Indonesian Center for Agricultural Development and Modernization of Mechanization.

#### Article 23

Indonesian Center for Agricultural Development and Modernization of Mechanization consists of:

- a. Administrative Section; and
- b. specialist positions and general service positions.

#### Article 24

The Administrative Section is responsible for carrying out the preparation of materials for program and budget planning, evaluation and reporting, financial affairs, human resource affairs, administrative services, general affairs, facilities and infrastructure, state property and asset management, correspondence, archiving, and public relations within the scope of Indonesian Center for Agricultural Development and Modernization of Mechanization.

### Part Five

#### Indonesian Center for Agricultural Development and Modernization of Postharvest

#### Article 25

- (1) Indonesian Center for Agricultural Development and Modernization of Postharvest is UPT under Indonesian Agency for Agricultural Development and Modernization and is responsible to the Head of the Agency.
- (2) Indonesia Center for Agricultural Development and Modernization of Postharvest is led by a Head.

#### Article 26

Indonesian Center for Agricultural Development and Modernization of Postharvest has the duties to carry out the agricultural development and modernization of postharvest.

#### Article 27

In performing the duties as referred to in Article 26, Indonesian Center for Agricultural Development and Modernization of Postharvest carries out the following functions:

- a. formulation of program plans and budgets in the field of agricultural development and modernization of postharvest;
- b. implementation of engineering and technological development, development of production capacity, and agricultural modernization of postharvest;
- c. management of products resulting from agricultural development of postharvest;

- d. utilization and cooperation related to the results of agricultural development and modernization of postharvest;
- e. planning, formulation, maintenance, and conformity assessment of Indonesian National Standard in the field of agricultural postharvest;
- f. monitoring, evaluation, and reporting in the field of agricultural development and modernization of postharvest; and
- g. implementation of administrative affairs and household management of Indonesian Center for Agricultural Development and Modernization of Postharvest.

#### Article 28

Indonesian Center for Agricultural Development and Modernization of Postharvest consists of:

- a. Administrative Section; and
- b. specialist positions and general service positions.

#### Article 29

The Administrative Section is responsible for carrying out the preparation of materials for program and budget planning, evaluation and reporting, financial affairs, human resource affairs, administrative services, general affairs, facilities and infrastructure, state property and asset management, correspondence, archiving, and public relations within the scope of Indonesian Center for Agricultural Development and Modernization of Postharvest.

### Part Six

Indonesian Center for Agricultural Development and Modernization of Biotechnology and Genetic Resources

#### Article 30

- (1) Indonesian Center for Agricultural Development and Modernization of Biotechnology and Genetic Resources is UPT under Indonesian Agency for Agricultural Development and Modernization and is responsible to the Head Agency;
- (2) Indonesian Center for Agricultural Development and Modernization of Biotechnology and Genetic Resources is led by a Head.

#### Article 31

Indonesian Center for Agricultural Development and Modernization of Biotechnology and Genetic Resources has the duties to carry out the agricultural development and modernization of biotechnology and genetic resources.

#### Article 32

In performing the duties as referred to in Article 31, Indonesian Center for Agricultural Development and Modernization of Biotechnology and Genetic Resources carries out the following functions:

- a. formulation of program plans and budgets in the field of agricultural development and modernization of biotechnology and genetic resources;
- b. implementation of technological engineering and development, development of production capacity, and agricultural modernization of biotechnology and genetic resources;
- c. implementation of technology analysis and testing in the field of agricultural development and modernization of biotechnology and genetic resources;
- d. management of source seed production and outcomes of agricultural development and modernization of biotechnology and genetic resources;
- e. management of agricultural genetic resources and agricultural gene banks;
- f. implementation of planning, formulation, maintenance, and conformity assessment of the Indonesian National Standard in the field of agricultural biotechnology and genetic resources;
- g. implementation of utilization and collaboration on the outcomes of the agricultural development and modernization of biotechnology and genetic resources;
- h. monitoring, evaluation, and reporting in the field of agricultural development and modernization biotechnology and genetic resources; and
- i. implementation of administrative and household affairs of Indonesian Center for Agricultural Development and Modernization of Biotechnology and Genetic Resources.

#### Article 33

Indonesian Center for Agricultural Development and Modernization of Biotechnology and Genetic Resources consists of:

- a. Administrative Section; and
- b. specialist positions and general service positions.

#### Article 34

The Administrative Section is responsible for carrying out the preparation of materials for program and budget planning, evaluation and reporting, financial affairs, human resource affairs, administrative services, general affairs, facilities and infrastructure, state property and asset management, correspondence, archiving, and public relations within the scope of Indonesian Center for Agricultural Development and Modernization of Biotechnology and Genetic Resources.

### Part Seven

#### Indonesian Center for Agricultural Development and Modernization of Implementation

#### Article 35

- (1) Indonesian Center for Agricultural Development and Modernization of Implementation is UPT under Indonesian Agency for Agricultural Development and Modernization and is responsible to the Head of Agency.

(2) Indonesian Center for Agricultural Development and Modernization of Implementation is led by a Head.

#### Article 36

Indonesian Center for Agricultural Development and Modernization of Implementation is responsible for development and application of outcomes from the development and engineering of technology packages, as well as the modernization of agriculture.

#### Article 37

In performing the duties as referred to in Article 36, Indonesian Center for Agricultural Development and Modernization of Implementation carries out the following functions:

- a. formulation of program, budgets, and cooperation plans in the field of agricultural development and modernization of implementation;
- b. implementation of engineering and development of location-specific technology packages;
- c. coordination of the implementation of outcomes from agricultural modernization and development;
- d. implementation of the application, dissemination, and technical guidance of agricultural modernization;
- e. development of methods and management of location-specific source seed/seeding production;
- f. identification and formulation of modern agriculture models;
- g. assessment of conformity with the Indonesian National Standard in the field of agricultural development and modernization of implementation;
- h. monitoring, evaluation and reporting in the field of agricultural development and modernization of implementation; and
- i. implementation of administrative and household affairs of Indonesian Center for Agricultural Development and Modernization of Implementation.

#### Article 38

Indonesian Center for Agricultural Development and Modernization of Implementation consists of:

- a. Administrative Section; and
- b. specialist positions and general service positions.

#### Article 39

The Administrative Section has the duties to carry out the preparation of materials for program and budget planning, evaluation and reporting, financial affairs, human resource affairs, administrative services, general affairs, facilities and infrastructure, state property and asset management, correspondence, archiving, and public relations within the scope of Indonesian Center for Agricultural Development and Modernization of Implementation.

**Part Eight**  
**Indonesian Institute for Agricultural Development and**  
**Modernization of Legumes**

**Article 40**

- (1) Indonesian Institute for Agricultural Development and Modernization of Legumes is UPT under Indonesian Agency for Agricultural Development and Modernization and is responsible to the Head of the Agency.
- (2) Indonesian Institute for Agricultural Development and Modernization of Legumes led by a Head.

**Article 41**

Indonesian Institute for Agricultural Development and Modernization of Legumes technically is supervised by the Director of Indonesian Center for Agricultural Development and Modernization of Food Crops.

**Article 42**

Indonesian Institute for Agricultural Development and Modernization of Legumes is responsible for conducting engineering, development, and testing, as well as the modernization of agriculture for various legume crops.

**Article 43**

In performing the duties as referred to in Article 42, Indonesian Institute for Agricultural Development and Modernization of Legumes carries out the following functions:

- a. implementation of activity plans and budgeting in the fields of engineering, development, testing, and modernization of various legume crops;
- b. implementation of engineering and technological development, as well as testing of various legume crops;
- c. implementation of source seed production and the outcomes of legume crop development;
- d. utilization of the outcomes from development and testing of various legume crops;
- e. formulation of Indonesian National Standard for various legume crops and conformity assessment;
- f. monitoring, evaluation, and reporting in the fields of engineering, development, testing, and modernization of various legume crops; and
- g. implementation of administrative and household affairs of Indonesian Institute for Agricultural Development and Modernization of Legumes.

**Article 44**

Indonesian Institute for Agricultural Development and Modernization of Legumes consists of:

- a. Administrative Subsection; and
- b. specialist positions and general service positions.

#### Article 45

Administrative Subsection is responsible for carrying out the preparation of materials for program and budget planning, evaluation and reporting, financial affairs, human resources, general administration, facility management, infrastructure and facilities, management of state-owned assets/property, correspondence, archiving, and public relations within the scope of Indonesian Institute for Agricultural Development and Modernization of Legumes.

#### Part Nine

#### Indonesian Institute for Agricultural Development and Modernization of Cereals

#### Article 46

- (1) Indonesian Institute for Agricultural Development and Modernization of Cereals is UPT under Indonesian Agency for Agricultural Development and Modernization and is responsible to the Head of the Agency.
- (2) Indonesian Institute for Agricultural Development and Modernization of Cereals is led by a Head.

#### Article 47

Indonesian Institute for Agricultural Development and Modernization of Cereals is technically supervised by the Director of Indonesian Center for Agricultural Development and Modernization of Food Crops.

#### Article 48

Indonesian Institute for Agricultural Development and Modernization of Cereals has the duties to conduct engineering, development, and testing, as well as the modernization of cereal crop agriculture.

#### Article 49

In performing the duties as referred to in Article 48, Indonesian Institute for Agricultural Development and Modernization of Cereals carries out the following functions:

- a. implementation of activity plans and budgeting in the fields of engineering, development, and testing, as well as the modernization of cereal crops;
- b. implementation of engineering and technological development, as well as testing of cereal crops;
- c. implementation of source seed production and outcomes of cereal crop development;
- d. utilization of outcomes from the development and testing of cereal crops;
- e. formulation of Indonesian National Standard for cereal crops and conformity assessment;
- f. monitoring, evaluation, and reporting in the fields of engineering, development, and testing, as well as modernization of cereal crops; and
- g. implementation of administrative and household affairs of Indonesian Institute for Agricultural Development and Modernization of Cereals.

Article 50

Indonesian Institute for Agricultural Development and Modernization of Cereals consists of:

- a. Administrative Subsection; and
- b. specialist positions and general service positions.

Article 51

Administrative Subsection is responsible for carrying out the preparation of materials for program and budget planning, evaluation and reporting, financial affairs, human resources, general administration, facility management, infrastructure and facilities, management of state-owned assets/property, correspondence, archiving, and public relations within the scope of Indonesian Institute for Agricultural Development and Modernization of Cereals.

Part Ten

Indonesian Institute for Agricultural Development and Modernization of Vegetables

Article 52

- (1) Indonesian Institute for Agricultural Development and Modernization of Vegetables is UPT under Indonesian Agency for Agricultural Development and Modernization and is responsible to the Head of the Agency.
- (2) Indonesian Institute for Agricultural Development and Modernization of Vegetables is led by a Head.

Article 53

Indonesian Institute for Agricultural Development and Modernization of Vegetables is technically supervised by the Director of Indonesian Center for Agricultural Development and Modernization of Horticulture.

Article 54

Indonesian Institute for Agricultural Development and Modernization of Vegetables is responsible for conducting engineering, development, and testing as well as the modernization of vegetable crop agriculture.

Article 55

In performing the duties as referred to in Article 54, Indonesian Institute for Agricultural Development and Modernization of Vegetables carries out the following functions:

- a. implementation of activity plans and budgeting in the fields of engineering, development, and testing, as well as the modernization of vegetable crops;
- b. implementation of engineering and technological development, as well as testing of vegetable crops;
- c. implementation of source seed production and outcomes of vegetable crop development;
- d. utilization of outcomes from the development and testing of vegetable crops;
- e. formulation of Indonesian National Standard for vegetable crops and conformity assessment;

- f. monitoring, evaluation, and reporting in the fields of engineering, development, and testing, as well as the modernization of vegetable crops; and
- g. implementation of administrative and household affairs of Indonesian Institute for Agricultural Development and Modernization of Vegetables.

**Article 56**

Indonesian Institute for Agricultural Development and Modernization of Vegetables consists of:

- a. Administrative Subsection; and
- b. specialist positions and general service positions.

**Article 57**

- e. implementation of the formulation of Indonesian National Standard concepts for agricultural Agro-climate and hydrology and conformity assessment;
- f. implementation of monitoring, evaluation, and reporting in the fields of engineering, development, and testing, as well as modernization of agricultural Agro-climate and hydrology; and
- g. administrative and household affairs management of the Indonesian Institute for Agricultural Development and Modernization of Agro-climate and Hydrology.

In performing the duties as referred to in Article 132, Indonesian Institute for Management of Agricultural Development and Modernization Product carries out the following functions:

- a. implementation of the preparation of activity and budget plans in the field of managing the results of agricultural engineering, development, standardization, and modernization;
- b. implementation of the management of the results of agricultural engineering, development, standardization, and modernization;
- c. implementation of control, utilization, and management of intangible assets and intellectual property rights resulting from agricultural development and modernization;
- d. implementation of monitoring, evaluation, and reporting in the field of managing the results of agricultural engineering, development, standardization, and modernization; and
- e. administrative and household affairs management of the Indonesian Institute for Agricultural Product Management.

#### Article 134

Indonesian Institute for Management of Agricultural Development and Modernization Product consist of:

- a. Administrative Subsection; and
- b. specialist positions and general service positions.

#### Article 135

Administrative Subsection is responsible for carrying out the preparation of materials for program and budget planning, evaluation and reporting, financial affairs, human resources, general administration, facility management, infrastructure and facilities, management of state-owned assets/property, correspondence, archiving, and public relations within the scope of Indonesian Institute for Management of Agricultural Development and Modernization Product.

- a. implementation of activity plans and budgeting in the field of engineering, development, and testing, as well as modernization of agriculture for various tuber crops;
- b. implementation of technological engineering and development, as well as testing of various tuber crops;
- c. implementation of foundation seed production and the outcomes of tuber crop development;
- d. implementation of utilization of the results of tuber crop Development and testing;
- e. implementation of the development of Indonesian National Standard concepts for various tuber crops and conformity assessment;
- f. implementation of monitoring, evaluation, and reporting in the field of engineering, development, and testing, as well as agricultural modernization of various tuber crops; and
- g. administrative and household affairs management of the Indonesian Institute for Agricultural Development and Modernization of Tubers.

**Article 146**

Indonesian Institute for Agricultural Development and Modernization of Tubers consists of specialist positions and general service positions.

**Article 148**

**Article 149**

Development and Modernization is responsible for carrying out Engineering, development, and testing, as well as the modernization of large ruminants.

**Article 150**

In performing the duties as referred to in Article 149, Indonesian Institute for Agricultural Development and Modernization of Large Ruminants carries out the following functions:

- a. implementation of activity plans and budgeting in the field of engineering, development, and testing, as well as modernization of large ruminants;
- b. implementation of Technological engineering and development, as well as testing of large ruminants;
- c. implementation of foundation seed/stock production and the outcomes of large ruminant development;
- d. implementation of the utilization of Development and testing results for large ruminants;
- e. implementation of the formulation of Indonesian National Standard concepts for large ruminants and conformity assessment;
- f. implementation of monitoring, evaluation, and reporting in the field of engineering, development, and testing, as well as modernization of large ruminants; and
- g. administrative and household affairs management of the Indonesian Institute for Agricultural Development and Modernization of Large Ruminants.

**Article 151**

**Part Twenty-Seven**

**Modernization of Small Ruminants**

**Article 152**

- (1) Indonesian Institute for Agricultural Development and Modernization of Small Ruminants is UPT under Indonesian Agency for Agricultural Development and Modernization and is responsible to the Head of the Agency.
- (2) Indonesian Institute for Agricultural Development and Modernization of Small Ruminants is led by a Head.

**Article 153**

Indonesian Institute for Agricultural Development and Modernization of Small Ruminants is technically supervised by Director of Indonesian Center for Livestock and Animal Health Development and Modernization.

**Article 154**

Indonesian Institute for Agricultural Development and Modernization of Small Ruminants is responsible for carrying out Engineering, development, and testing, as well as the modernization of small ruminants.

**Article 155**

In performing the duties as referred to in Article 154, Indonesian Institute for Agricultural Development and Modernization of Small Ruminants carries out the following functions:

- a. implementation of activity plans and budgeting in the field of engineering, development, and testing, as well as modernization of small ruminants;
- b. implementation of Technological engineering and development, as well as testing of small ruminants;
- c. implementation of foundation seed/stock production and the outcomes of small ruminant development;
- d. implementation of the utilization of Development and testing results for small ruminants;
- e. implementation of the formulation of Indonesian National Standard concepts for small ruminants and conformity assessment;
- f. implementation of monitoring, evaluation, and reporting in the field of engineering, development, and testing, as well as modernization of small ruminants; and
- g. administrative and household affairs management of the Indonesian Institute for Agricultural Development and Modernization of Small Ruminants.

**Article 156**

Indonesian Institute for Agricultural Development and Modernization of Small Ruminants consists of specialist positions and general service positions.

## CHAPTER IV SPECIALIST POSITIONS AND GENERAL SERVICE POSITIONS

### Article 157

Specialist positions and general service positions may be established within the Technical Implementation Units under the scope of the Agency for Agricultural Development and Modernization as needed, with implementation carried out in accordance with the provisions of prevailing legislation.

### Article 158

- (1) Specialist positions and staff are responsible for providing functional services in carrying out the duties and functions of the Technical Implementation Unit (UPT) in accordance with their field of expertise and skills.
- (2) In performing the duties referred to in section (1), specialist positions and general service positions may work individually and/or in a work team to support the achievement of organizational goals and performance.
- (3) The work team referred to in section (2) consists of:
  - a. a team leader; and
  - b. team members.
- (4) The work team as referred to in section (3) carries out tasks based on assignments from the head of the UPT.
- (5) In assigning tasks to the work teams, the head of the UPT as referred to in section (4) must take into account the competencies and expertise relevant to the needs of task implementation.
- (6) The team leader coordinates and manages activities in accordance with their area of responsibility.
- (7) The implementation of tasks and assignments by functional and general service positions is conducted in accordance with the provisions of the prevailing legislation.

### Article 159

- (1) Specialist positions and general service positions as referred to in Article 158, consist of various types of functional and general service positions according to their respective fields of expertise, with appointments carried out in accordance with the provisions of the prevailing legislation.
- (2) The number of specialist positions and general service positions, as referred to in section (1), is determined based on organizational needs established through job analysis and workload assessment.
- (3) The duties, types, and levels of specialist positions is carried out in accordance with the provisions of the prevailing legislation.

## CHAPTER V WORK METHOD

### Article 160

Head of UPT in carrying out their duties and functions, must implement the government agency performance accountability system.

Article 161

- (1) The UPT must develop a business process that outlines effective and efficient working relationships among organizational units within the UPT.
- (2) The business process among organizational units within the UPT, as referred to in section (1), is established by the Minister.

Article 162

Head of UPT submits reports to the Head of the Agency regarding the results of the implementation of their duties and functions periodically or at any time as needed.

Article 163

UPT must prepare job analysis, job maps, workload analysis, and job descriptions for all positions within the UPT.

Article 164

Each element within the UPT, in carrying out its duties and functions, must apply the principles of coordination, integration, and synchronization both within the scope of UPT and in relations among government agencies at the central and regional levels.

Article 165

Each element within the UPT must implement the government internal control system within their respective environments in accordance with the provisions of the prevailing legislation.

Article 166

- (1) Each head of an organizational unit is responsible for leading and coordinating subordinates, as well as providing guidance and instructions for the implementation of tasks in accordance with the established job descriptions.
- (2) The guidance and instructions referred to in section (1) must be responsibly followed and complied with by subordinates and reported periodically in accordance with the provisions of the prevailing legislation.

Article 167

In carrying out their duties, each head of an organizational unit provides guidance and supervision to the organizational units under their authority.

CHAPTER VI  
ROLE POSITIONS

Article 168

- (1) Head of the Indonesian Center is a Primary High Leadership Position or Echelon II.b. structural position.
- (2) Head of the Institute is an Administrator Position or Echelon III. A structural position.

- (3) Head of the Administrative Section is an Administrator Position or Echelon III.b. structural position
- (4) Head of the Subsection of General Administration is a Supervisory Position or Echelon IV.a. structural position.

## CHAPTER VII NUMBER, NAME, LOCATION, AND WORKING AREA

### Article 169

- (1) The Technical Implementation Units (UPT) under the Indonesian Agency for Agricultural Development and Modernization consist of 7 (seven) Indonesian centers, 49 (forty-nine) centers, and 3 (three) local units.
- (2) The names, locations, and working areas of the UPT under Indonesian Agency for Agricultural Development and Modernization are listed in Annex II, which forms an integral part of this Ministerial Regulation.

## CHAPTER VIII ORGANIZATIONAL STRUCTURING

### Article 170

Changes to the organization and work procedures of the Technical Implementation Units (UPT) within Indonesian Agency for Agricultural Development and Modernization are determined by the Minister after obtaining written approval from the minister administering government affairs in the field of state apparatus.

## CHAPTER IX TRANSITIONAL PROVISION

### Article 171

At the time this Ministerial Regulation comes into force, All positions and the officials holding those positions within the Technical Implementation Units under the Agricultural Instrument Standardization Agency, as regulated in Minister of Agriculture Regulation Number 13 of 2023 on Organization and Work Procedures of Technical Implementation Units under the Indonesian Agency for Agricultural Instrument Standardization, remains effective and continue to carry out their duties and functions until new positions are established and new officials are appointed pursuant to this Ministerial Regulation.

## CHAPTER X CLOSING PROVISIONS

### Article 172

At the time this Ministerial Regulation comes into force, Regulation of the Minister of Agriculture Number 13 of 2023 on Organization and Work Procedures of Technical Implementation Units within the Indonesian Agency for Agricultural Instrument Standardization (State Bulletin of the Republic of Indonesia of 2023 Number 119), is repealed and declared ineffective.

Article 173

This Ministerial Regulation comes into force on the date of its promulgation.

In order that every person may know hereof, it is ordered to promulgate this Ministerial Regulation by its placement in the State Bulletin of the Republic of Indonesia.





DEVELOPMENT AND MODERNIZATION


