NUMBER 81 OF 2024
ON
ACCELERATION OF FOOD DIVERSIFICATION
BASED ON LOCAL POTENTIAL RESOURCES

BY THE BLESSINGS OF ALMIGHTY GOD

PRESIDENT OF THE REPUBLIC OF INDONESIA,

Considering : a. that in order to strengthen a resilient national food system and enhance the quality of human resources, as well as utilize natural resources in a sustainable manner, it is necessary to undertake systematic, synergistic, integrated and coordinated efforts in food diversification based on local potential resources; b. that food diversification based on local potential resources needs to be accelerated; c. that based on the considerations as referred to in point a and point b, it is necessary to issue a Presidential Regulation on Acceleration of Food Diversification Based on Local Potential Resources;

Observing : Article 4 section (1) of the 1945 Constitution of the Republic of Indonesia;

HAS DECIDED:

To issue : PRESIDENTIAL REGULATION ON ACCELERATION OF FOOD DIVERSIFICATION BASED ON LOCAL POTENTIAL RESOURCES.

CHAPTER I
GENERAL PROVISIONS

Article 1

In this Presidential Regulation:

1. Food Diversification means an effort to increase the availability and consumption of diverse food, nutritionally balanced and based on local potential resources.
2. Food means any substance originating from biological sources product of agriculture, plantation, forestry, fishery, livestock, waterworks and water sources, both

processed and unprocessed, designated as food or beverage for human consumption, including food additives, food raw materials and other materials used in the process of preparing, processing and/or producing food or beverage.

3. Local Food means food that is consumed by local community according to local potential and wisdom.
4. Diverse, Nutritionally Balanced, and Safe (*Beragam, Bergizi Seimbang, dan Aman*) Food hereinafter referred to as B2SA Food means a combination of various food sources of carbohydrate, protein, fat, vitamin, mineral, fiber, water, and other components that comply with food safety standards for a healthy, active, and productive life.
5. National Action Plan for Acceleration of Food Diversification Based on Local Potential Resources (*Rencana Aksi Nasional Percepatan Penganekaragaman Pangan Berbasis Potensi Sumber Daya Lokal*), hereinafter abbreviated to RAN-P3BPSDL means a document containing strategic objective to be used as a reference by the ministries/government agencies and Local Governments in the acceleration of Food Diversification.
6. Desirable Dietary Pattern (*Pola Pangan Harapan*) hereinafter abbreviated to PPH means an indicator of the quality of Food diversity that describes the contribution of energy within the composition of the main Food group at the level of availability and/or Food consumption.
7. Food Business Operator means Any Person that is engaged in one or more Food agribusiness subsystems, including supplier of production input, production process, processing, marketing, trading and supporting.
8. Local Food Business Operator means any person engaged in one or more Local Food agribusiness subsystems, including suppliers of production input, production process, processing, marketing, trading and supporting activities.
9. Micro, Small, and Medium Enterprises, hereinafter referred to as MSMEs mean micro enterprises, small enterprises, and medium enterprises as defined in the Law on Micro, Small, and Medium Enterprises.
10. Local Government means the regional head as an element of local government administrator who leads the implementation of government affairs which is under the authority of the autonomous region.
11. National Food Agency hereinafter referred to as Agency, means a government agency that is under and responsible to the President and has the task of implementing government duties in the Food sector.
12. Village Government means to the village head, or by any other title, assisted by the village apparatus, as the element responsible for administering village governance.
13. Stakeholders mean individuals, communities, academics, professional organizations, business

sectors, mass media, civil society organizations, higher education institutions, public figures, religious figures, and development partners involved in the acceleration of Food diversification based on local potential resources.

Article 2

The Acceleration of Food Diversification based on local potential resources takes into account local wisdom.

CHAPTER II OBJECTIVES AND TARGETS

Article 3

The Acceleration of Food Diversification based on local potential resources aims to:

- a. increase the availability of diverse Food based on local potential resources to meet Food consumption needs in adequate quantity and quality, that is varied, nutritionally balanced, safe, equitably distributed, accessible, and aligned with community preferences;
- b. increase public affordability to a variety of Food based on local potential resources that is equitably distributed and affordable;
- c. increase the utilization of Food to meet B2SA Food consumption based on local potential resources; and
- d. accelerate the development of Food business based on local potential resources, specifically MSMEs and small and medium industries by increasing the roles of ministries/government agencies, provincial Governments, regency/municipal Governments, and Local Food Business Operators through facilitation and improved access to Food standards, technologies, funding, markets, and business incentives.

Article 4

The objectives of implementing the acceleration of Food Diversification based on local potential resources are to:

- a. ensure the availability of diverse Food to meet B2SA Food consumption in adequate quantity;
- b. achieve public access to a variety of Food based on local potential resources that is equitably distributed and affordable;
- c. achieve the utilization of Food in accordance with the B2SA Food consumption pattern; and
- d. achieve the development of Food business based on local potential resources, and the strengthening of the roles of ministries/ government agencies, provincial Governments, regency/municipal Governments, Village Governments, and Local Food Business Operators through facilitation and improved access to Food standards, technologies, funding, markets, and business incentives.

CHAPTER III NATIONAL STRATEGIES

Article 5

- (1) The objectives as referred to in Article 4, are implemented based on the national strategies for the acceleration of Food Diversification based on local potential resources.
- (2) The national strategies for the acceleration of Food Diversification based on local potential resources consist of:
 - a. strengthening policy/regulatory support for the development of Local Food;
 - b. mainstreaming the production and consumption of Local Food;
 - c. optimizing the land utilization, including yard land;
 - d. strengthening and developing the Local Food industry, specifically MSMEs and/or small and medium industries;
 - e. increasing the distribution and marketing reach of processed Food products based on local potential resources efficiently;
 - f. increasing public knowledge, awareness, and attitude regarding the importance of consuming B2SA Food;
 - g. developing technology and incentive system for Local Food business; and
 - h. strengthening the economic institution of farmers, fish farmers, and fishers.
- (3) The national strategies for the acceleration of Food Diversification based on local potential resources as referred to in section (2) are listed in Annex, as an integral part of this Presidential Regulation.

Article 6

- (1) The national strategies for the acceleration of Food Diversification based on local potential resources serve as a guideline for ministries/government agencies, provincial Governments, regency/municipal Governments, and Food Business Operator in implementing Food Diversification.
- (2) Ministries/government agencies implement the national strategies for the acceleration of Food Diversification based on the local potential resources in accordance with their respective duties and functions.
- (3) Provincial Governments and regency/municipal Governments implement the national strategies for the acceleration of Food Diversification based on the local potential resources in accordance with the provisions of legislation.
- (4) Food Business Operators implement the acceleration of Food Diversification based on the local potential resources in accordance with their respective business sectors.

Article 7

- (1) The national strategies for the acceleration of Food Diversification based on the local potential resources are implemented to achieve the target of the B2SA Food consumption for a healthy, active, and productive life.
- (2) In order to achieve the target as referred to in section (1), the measurement of the PPH score is carried out.
- (3) PPH score target as referred to in section (2) refers to the 2020–2024 National Medium-Term Development Plan, with a target score of 95.2 (ninety-five point two) for 2024.
- (4) PPH score target as referred to in section (3) is elaborated into achievement indicator, year and target achievement, ministries/government agencies in charge, and supporting ministries/government agencies.
- (5) The national PPH score target for the period of 2025–2030 refers to the 2025–2029 National Medium-Term Development Plan.

CHAPTER IV
ACTION PLANS

Article 8

- (1) In order to implement the national strategy for accelerating Food Diversification based on local potential resources and meet the national PPH target, the RAN-P3BPSDL is issued nationally.
- (2) The RAN-P3BPSDL as referred to in section (1) is established for the period of 2024–2030.
- (3) The RAN-P3BPSDL refers to the National Medium-Term Development Plan.
- (4) In addition to referring to the National Medium-Term Development Plan as referred to in section (3), the RAN-P3BPSDL is formulated with due consideration to:
 - a. Food availability to meet the needs of B2SA food consumption based on local potential resources across all regions throughout the year;
 - b. the needs of B2SA food consumption to achieve the PPH score target, with due regard to local potential resources;
 - c. the carrying capacity of natural resources, economic resources, human resources, technology, and environmental sustainability;
 - d. national and regional development plans and spatial planning; and
 - e. the roles of ministries/government agencies, provincial Governments, regency/municipal Governments, Village Government, and Stakeholders.
- (5) The RAN-P3BPSDL as referred to in section (2) is listed in Annex, as an integral part of this Presidential Regulation.
- (6) In the event of any strategic change in national policy, the RAN-P3BPSDL is amended and issued in a Presidential Regulation.

Article 9

- (1) In order to support the acceleration of Food Diversification based on local resources, governors and regents/mayors develop and issue regional action plans.
- (2) The regional action plans as referred to in section (1) must be aligned with the RAN-P3BPSDL, the provincial Medium-Term Regional Development Plan, and the regency/municipal Medium-Term Regional Development Plan.
- (3) In addition to referring to the RAN-P3BPSDL, the Provincial Medium-Term Regional Development Plan, and the regency/municipal Medium-Term Regional Development Plan as referred to in section (2):
 - a. the formulation of provincial regional action plan must take into account the needs and proposals of regency/municipality; and
 - b. the formulation of regency/municipal action plans must take into account the needs and proposals of Village.

CHAPTER V
IMPLEMENTATION

Article 10

- (1) The national strategies for the Acceleration of Food Diversification as referred to in Article 5, and the action plans as referred to in Article 8, serve as a reference for ministries/government agencies, provincial Governments, regency/municipal Governments, and stakeholders in implementing the national acceleration of Food Diversification based on local potential resources.
- (2) In implementing the acceleration of Food Diversification as referred to in section (1), ministries/government agencies, provincial Governments, and regency/municipal Governments carry out programs and activities to accelerate national Food Diversification based on local potential resources.
- (3) In implementing the programs and activities as referred to in section (2), ministries/government agencies, provincial Governments, and regency/municipal Governments carry out:
 - a. strengthening of planning and budgeting;
 - b. improvement of implementation quality;
 - c. improvement of the quality of monitoring, evaluation, control, and reporting; and
 - d. enhancement of human resource capacity.

Article 11

- (1) The implementation and organization of the national strategies and action plans for the acceleration of food diversification based on local potential resources at the national level are coordinated and carried out by the Agency.

(2) The implementation and organization of the national strategies and action plans for the acceleration of Food Diversification based on local potential resources at the regional level are coordinated and carried out by governors and/or regents/mayors in accordance with their respective authority.

CHAPTER IV MONITORING, EVALUATION, SUPERVISION, CONTROL, AND REPORTING

Part One Monitoring and Evaluation

Article 12

Monitoring and evaluation are intended to:

- a. know the progress and success of implementing the acceleration of Food Diversification based on local potential resources;
- b. provide feedback for improving the implementation of the acceleration of Food Diversification based on local potential resources;
- c. serve as a consideration for planning and budgeting, as well as for enhancing the accountability of the acceleration of Food Diversification based on local potential resources;
- d. provide an assessment of the alignment of activities, performance indicators, and target of the RAN-P3BPSDL; and
- e. serve as a consideration for providing a recommendation to achieve the successful implementation of the acceleration of Food Diversification based on local potential resources.

Article 13

- (1) Monitoring and evaluation are carried out by the ministries/government agencies in charge of the activity, as well as by supporting ministries/agencies.
- (2) The results of the monitoring and evaluation as referred to in section (1) are submitted to the Head of Agency.

Article 14

- (1) Monitoring and evaluation at the provincial and regency/municipal levels are conducted by governors and regents/mayors.
- (2) The results of the monitoring and evaluation as referred to in section (1) are submitted to the Head of Agency, with a copy to the minister administering government home affairs.

Part Two Supervision and Control

Article 15

Supervision and control are aimed to:

- a. know the achievement of the implementation of Food Diversification acceleration based on the local potential resources;
- b. ensure the implementation of the action plans for the acceleration of Food Diversification based on the local potential resources in accordance with the planning; and
- c. identify potential obstacles and constraints in the implementation of the acceleration of Food Diversification based on the local potential resources.

Article 16

- (1) Supervision and control are carried out by the ministries/government agencies in charge of the activities and the supporting ministries/ government agencies.
- (2) The results of the supervision and control as referred to in section (1) are submitted to the Head of Agency.

Article 17

- (1) Supervision and control at the provincial and regency/municipal levels are carried out by the governors and the regents/mayors.
- (2) The results of the supervision and control as referred to in section (1) are submitted to the Head of Agency with a copy to the minister administering government home affairs.

Part Three
Reporting

Article 18

- (1) Reporting on achievements and the results of monitoring, evaluation, supervision, and control of the implementation of the acceleration of Food Diversification based on the local potential resources are carried out by the ministries/government agencies in charge of activity and the supporting ministries/agencies, and are submitted to the Head of Agency.
- (2) Reporting on achievements and the results of monitoring, evaluation, supervision, and control of the acceleration of Food Diversification based on the local potential resources is conducted in a hierarchical manner by the regents/mayors to the governors, and by the governors to the Head of Agency.
- (3) The report as referred to in section (2) is submitted with a copy to the minister administering government home affairs.
- (4) The Head of Agency reports the report results as referred to in section (1) and section (2) to the President.

Article 19

- (1) Monitoring, evaluation, supervision, control, and reporting of the implementation of the acceleration of Food Diversification based on the local potential

resources as referred to in Article 13, Article 14, Article 16, Article 17, and Article 18 are carried out 2 (two) time in 1 (one) year or at any time if necessary.

(2) Further provisions regarding the procedures for monitoring, evaluation, supervision, control, and reporting are regulated by a Regulation of the Head of Agency.

CHAPTER VII FUNDING

Article 20

The funding for the implementation of the acceleration of Food Diversification based on the local potential resources is sourced from:

- a. the state budget;
- b. the local budget; and/or
- c. other lawful and non-binding sources in accordance with the provisions of legislation.

CHAPTER VIII CLOSING PROVISION

Article 21

This Presidential Regulation comes into force on the date of its promulgation.

In order that every person may know hereof, it is ordered to promulgate this Presidential Regulation by its placement in the State Gazette of the Republic of Indonesia.
