BY THE BLESSINGS OF ALMIGHTY GOD

PRESIDENT OF THE REPUBLIC OF INDONESIA,

- Considering : a. that in order to protect the entire Indonesian nation and all of Indonesia's territory and to advance people's welfare, improve the nation's intelligence, and participate in implementing world order based on independence, eternal peace, and social justice, the Government of the Republic of Indonesia as a part of the international community carries out international relations and cooperation which are manifested in treaties;
- b. that in order to enhance cooperation in the field of law enforcement, the Government of the Republic of Indonesia and the Government of the Republic of Singapore have signed the Treaty between the Government of the Republic of Indonesia and the Government of the Republic of Singapore for the Extradition of Fugitives on 25 January 2022 in Bintan, Indonesia, so that it is necessary to follow up by ratifying the Treaty in accordance with Law Number 24 of 2000 on Treaties;
- c. that based on the considerations as referred to in point a and point b, it is necessary to establish a Law on Ratification of Treaty between the Government of the Republic of Indonesia and the Government of the Republic of Singapore for the Extradition of Fugitives;
- Observing : 1. Article 5 section (1), Article 11, and Article 20 of the 1945 Constitution of the Republic of Indonesia;
2. Law Number 24 of 2000 on Treaties (State Gazette of the Republic of Indonesia of 2000 Number 185, Supplement to the State Gazette of the Republic of Indonesia Number 4012);

With the Joint Approval of  
THE HOUSE OF REPRESENTATIVES OF THE REPUBLIC OF INDONESIA  
and  
THE PRESIDENT OF THE REPUBLIC OF INDONESIA

HAS DECIDED:

To issue : LAW ON RATIFICATION OF TREATY BETWEEN THE  
GOVERNMENT OF THE REPUBLIC OF INDONESIA AND THE  
GOVERNMENT OF THE REPUBLIC OF SINGAPORE FOR THE  
EXTRADITION OF FUGITIVES.

Article 1

Ratifies the Treaty Between the Government of the Republic of Indonesia and the Government of the Republic of Singapore for the Extradition of Fugitives (which was signed on 25 January 2022 in Bintan, Indonesia, of which authentic Indonesian and English text are attached to this ratification as an integral part of this Law.

Article 2

This Law comes into force on the day of its promulgation.

In order that every person may know hereof, it is ordered to promulgate this Law by its placement in the State Gazette of the Republic of Indonesia.

FOR THE EXTRADITION OF FUGITIVES

I. GENERAL

In order to achieve the state goals of the Republic of Indonesia in protecting the entire Indonesian nation and all of Indonesia's territory and to advance people's welfare, improve the nation's intelligence, and participate in implementing world order based on independence, eternal peace, and social justice as mandated in the Preamble of the 1945 Constitution of the Republic of Indonesia, the Government of the Republic of Indonesia as a part of the international community carries out international relations and cooperation which are manifested in treaties.

The development of science and technology, especially advanced transportation, communication, and information technologies, have resulted in between territory of one country and another country to seem borderless so it eases the traffic and people's transportation. It also gives a higher chance for suspects or perpetrators of offences to run away from investigation, prosecution, examination in court, or serve a sentence in a country where the offence being committed.

Being aware of this situation, the Government of the Republic of Indonesia and the Government of the Republic of Singapore have signed the Treaty between the Government of the Republic of Indonesia and the Government of the Republic of Singapore for the Extradition of Fugitives on 25 January 2022 in Bintan, Indonesia. With this Treaty, the relation and cooperation between both countries in the field of law enforcement and eradication of offence based on the mutual benefit principle is expected to grow further.

The Treaty between Government of the Republic of Indonesia and the Government of the Republic of Singapore regulates the agreement of the Parties to extradite, extraditable offences, basis for extradition, mandatory exceptions to extradition, the request and supporting documents, and arrangement for surrender.

The enactment of Law on Ratification of Treaty between the Government of the Republic of Indonesia and the Government of the Republic of Singapore for the Extradition of Fugitives will support the law enforcement in Indonesia.
